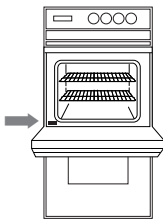

Front edge (open door)



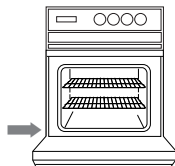
Over-the-Range Microwave Ovens
Left wall (open door)



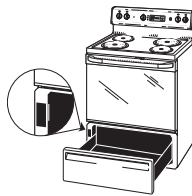
Vent Hoods
Inside left wall.



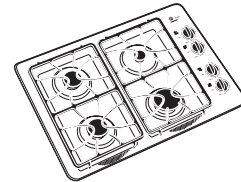
Double Ovens

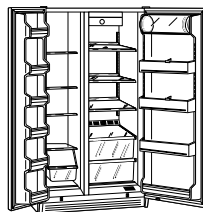

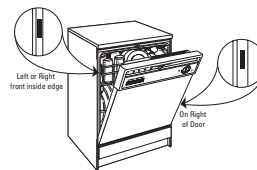
